

It is a beautiful full colored magazine with lots of pictures, articles written by the Board of Doctors, testimonials of other readers about their successful treatment, and just plain positive "good reading." You will also receive the latest annual publication called Drug Guide (many new drugs and their uses,) 10% discount on books, videos you see in the magazine. And \$14 of your membership is deductible as charity from your income taxes. I really feel strongly about the good your Foundation Membership does.

In future articles I will write about five proven habits that will make life with Arthritis easier.
They are:

Learn as much as you can about the disease to help your doctor help you.

Keep a positive attitude.

Make a Rheumatologist (doctor specialist) a partner in your care.

Dear members,



Twin Falls - Laura May Colvin McAnulty, 101, formerly of Hagerman and Wendell died Tuesday, Nov. 29, 2016 at Syringa Place in Twin Falls.

Laura was born Oct. 14, 1915 to Fred and Edith Bray Colvin at Blanche, Idaho.

She was raised on the Snake River at Bliss and graduated from Bliss High School in 1934. She married



Rex W. McAnulty on April 5, 1935. Together they had four children.

Rex and Laura lived at Glenns Ferry for a time, and at Swanholm on the middle fork of the Boise River. They settled in Hagerman for 47 years while Rex worked for Idaho Power. After Rex died in 1996, Laura moved to Wendell where she resided until moving to Syringa Place in 2014.

She was a member of the Methodist Church, and of Union Rebekah Lodge #45, being a Past Noble Grand. She was also a Past President of the Department Association of the Ladies Auxiliaries Patriarchs Militant I.O.O.F. of Idaho.

In addition to being a homemaker, Laura worked for many years for the Hagerman School District. She enjoyed reading, camping, gardening, going on picnics, playing pinochle and spending time with family and friends.

Laura is survived by her children; Gene and Carmelina McAnulty of Winter Springs, FL, Sharon and Bob Moore of Jerome, ID and Sam and Janey McAnulty of Meridian, ID; her son-in-law Chet Inscore of Caldwell, ID, 13 grandchildren, 20 great grandchildren and 12 greatgreat grandchildren, one sister Jean Markham of Mountain Home, ID and a sister-in-law Elva McAnulty of Wendell, ID.

She was preceded in death by her husband Rex, her daughter Barbara Inscore, 3 grandchildren: Alan Peterson, Teresa Peterson and Brenda Moore Inskeep, 6 sisters and 3 brothers.

Laura was honored to celebrate her 100th Birthday with her family and friends.

Funeral services were held on Saturday, Dec. 3, 2016 at the Hagerman United Methodist Church. Burial followed at the Hagerman Cemetery.


